** Sailboat Update

The Owners have until the end of February to finish removing the bottom of their boat that washed ashore in July of 2015. No attempt to complete removal has been made since they left the island last year.

If it's not removed from the beach by the end of February the court will most likely issue a bench warrant for the owners to appear in court again to explain their side of the story and give them more time to remove the boat.

Roger DeBruler, from Charlotte County, suggested the LGPOA implore islanders to complain to the court in writing about our exact issues with the delays and the infringement of the debris. He said, as voters we have more pull with the court and attorney generals' office than governmental agencies.

Reasons in your complaint could be any or all of the following. Turtle season is fast approaching in mid-April. The ladies have been given a minimal amount of court costs and plenty of time for removal already. There has been a change to the water flow along the shoreline. And lastly, the jagged edges of the boats' remains are dangerous during high tides.

He recommends sending a letter to the Prosecuting Attorney Andrew Barnett and one to the Honorable Paul Alessandroni. Both can go in the same envelope to the State Attorney's Office, 350 E Marion Ave, Punta Gorda, FL 33950. State your reasons for your exact issues with the delays and the infringement of the debris and refer to case number 15001518M. You can also request a notification of any upcoming court dates and your return address.

Hopefully our letters will make a difference when the judge decides what to do next.

Wildlife Rescue

Islanders Lori and Melissa are addressing wildlife rescues for injured birds and other critters on the island, beaches, and marinas. They are working with the Wildlife Center of Venice. If you see injured wildlife, please notify Lori and Melissa through the Little Gasparilla Island Facebook page or call Wildlife Center of Venice at 941-484-9657. http://wildlifecenterofvenice.org/

Lori and Melissa have rescued many birds this past month. They asked to remind us that if you are cleaning fish, please do not throw the bones/skeleton where pelicans can grab them. Pelicans have needed help when they get the bones stuck in their throats. Dispose of fish bones well away from pelicans, in an area where the bones can sink quickly to the bottom. Some pelicans have been seen in distress from attempting to ingest plastic bags. Be aware that your litter can look like food to wildlife. There have also been many instances where birds with embedded fishhooks need rescue assistance. If you hook a bird, reel it in and remove the hook – do not just cut the line. Lori and Melissa are in need of dog or cat crates to use to transport injured wildlife. If you have a crate to donate, please contact them through the Facebook page. Thank you!
