## \*\*What Is This? Diodon holocanthus is known as Balloon fish by Laurie Tremblay

The balloon fish has an average size of 8-14 inches, and has long spines over the entire body. It feeds on mollusks, crabs, and urchins. They can be found in tropical waters living in grassy areas, coral reefs, and mangroves. This fish will take in water when frightened, thus expanding its size. The spines will stand erect intimidating potential predators. Relatives are the porcupinefish and burrfish (shorter spines).

Do you need to haul your household items off the island?



Sea Turtles



Turtle nests began hatching in late June. It is imperative that lights are OUT on the

beach as hatchlings can and will disorient with any artificial light. They head away from

the ocean and toward any house with lighting, phone flashes/lights or flashlights.

What can you do to help this turtle hatching season?

1. Please turn off exterior lights (and pull shades/draw curtains) on your

beach front homes.

2. Use only red filters for flashlights or phones. Use the phone app.

3. Cover any holes that you may dig or that you see on the beach.

4. Remove all beach furniture and take away any trash.

5. Keep your dog leashed on the beach and remove your dog's excrement as well.

6. Do your best to help with rental houses on the island as the renters

come and go quickly and re-education with each rental is important.



Mosquito population on the rise!

A mosquito's attraction to humans is complex. Mosquitoes are attracted to the carbon dioxide coming from the breath and pores of humans. In addition, some mosquito species are attracted to certain fragrances and colors. If you wish to be less attractive to mosquitoes, try using products that are unscented (i.e., hair spray, deodorant, soap, etc.) and light-colored clothing. You can also try wearing commercially available, proven mosquito repellents. The most proven repellent is Ndi ethyl-metatoluamide or DEET. Be sure to read the entire label before using.

Charlotte County has over 37 species of mosquitoes! The county does do aerial spraying as well as ground spraying from an ATV. We have learned that the ground spraying is much more effective. When mosquito populations get out of control, call Charlotte County Mosquito Control and leave a message requesting ground spraying

#### **Hurricane Season Reminder**

If you stay on the island for a small storm, have what you need to survive for a few days. Medications, spare oxygen if needed for CPAP, or other breathing device, first aid kit, water, food, gas and generator for 3 days minimum. If you are asked to evacuate the island, do so in a timely manner. If you are asked to leave by LGIFR, Charlotte County Fire or the Sheriff it is for a reason and not to be taken lightly.

#### \*\*Sewer Project Update by Barb Dwyer

As most of you have heard, the Public Service Commission (PSC) denied the certificate for Environmental Utilities (EU) to install a sewer system on Little Gasparilla, Don Pedro & Knight Islands at their meeting on June 7, 2022. The final order was posted on July 8, 2022.

EU filed a motion for reconsideration of the decision on July 22, 2022. The standard of review for reconsideration of a Commission Order is whether the motion identifies a point of fact or law

that the Commission overlooked or failed to consider in rendering the order. Granting a reconsideration must be based upon specific factual matters set forth in the record and susceptible to review.

On June 28, 2022, Charlotte County (CC) Commissioner William Truex submitted a letter in support of EU's request. This letter was posted well after the record was closed in February 2022 and after the PSC voted to deny the certificate on June 7, 2022.

On July 29, 2022, the Office of Public Counsel (OPC) objected to EU's attempted use of the unauthorized June 28th CC letter. The OPC filed a response solely for the purpose of protecting the record in this case and for principles of fairness in Florida PSC proceedings. This letter is not within the record of the case & cannot form the basis for reconsideration. No party was given the opportunity to conduct discovery, depose the author, or conduct cross-examination on the assertions. The OPC requests that the EU motion is denied.

On August 26, 2022, the PSC Staff submitted their recommendation to the PSC Commissioners. The staff disagreed with EU that there are points of fact or law that the Commission overlooked or failed to consider in denying EU's application. EU has offered only reargument to support their claims. The PSC staff recommends that EU's reconsideration should be denied.

The PSC Commissioners will vote at their Conference on September 8, 2022.
