(The pines have caused major destruction over the years due to their large size and shallow root system. The peppers are a haven for mosquitoes. Native plants could be used to replace these.)
4. Do you think some narrow parts of our "roadway" should be widened and stabilized to allow for safer travel?
Please rank these 4 questions in order of importance to you. For example, a rank of 2, 1, 4, 3 would mean that question 2 has the highest importance and urgency and question 3 has the least importance and urgency.
This information will provide the LGPOA with some guidelines for island improvement.


## • County Bridgeless Barrier Island Accessibility meeting submitted by Barb

I attended the Charlotte County (CC) Bridgeless Barrier Island (BBI) Accessibility meeting on Nov 13th. The meeting was hosted by Chris Beers of Johnson Engineering & Travis Perdue - CC Facilities Management Director. There were over 90 people in attendance.

This meeting was a follow up to a meeting in January 2024 when CC hired Johnson Engineering to gather info about the accessibility needs of Knight Island, Thornton Key, Don Pedro Island & LGI. The first survey results & the responses from the first meeting indicated that the needs of LGI are significantly different than the other 3 islands. It was mentioned that there were 249 responses from LGI out of 642 homes. Yesterday's meeting is still considered Phase 1 - the information gathering portion. A second survey has been created to get information from the 2 areas separately. Attached is a picture of the QR code given out with a link to the second survey. Further info can be found on the Charlotte County website.

My takeaway from the discussions shared & comments made by LGI homeowners after the meeting is that we need to provide CC with specific needs for HBBC & LGI. There needs to be a convenient mainland barge landing for delivery & transport of goods, and for service & septic providers to have access to the island. There needs to be a dedicated barge landing on the island to allow for competition. There needs to be access to public parking & boat trailer parking for times of heavy occupancy & for those owners or renters who have boats. The possibility that Eldred's will not remain a public marina has heightened the need for CC to fill in the gaps. The possibility that the Fishery barge landing might no longer be available for use compounds the severity of our needs.

It is important that every homeowner fill out the survey and that they add comments at the end to ensure that CC understands the needs of our community on LGI. The more people that respond to the survey, the more likely CC will have to listen to our concerns.
